An administration fee equal to 15% of the sale price of each piece of artwork will be collected to offset the Art on the Square event expenses. Sales tax will be collected for the sale of the artwork for the artist. The sales tax will be mailed to the artist within three (3) weeks of the conclusion of the event. It is the responsibility of the artist to pay the appropriate agency the sales tax for all items sold at the Art on the Square event.

I understand that the Lodi Arts Commission does not provide property or liability insurance for artists for this event and I further understand that I may provide this insurance at my own expense if I so desire.

Through this agreement I expressly agree to release and hold harmless the Lodi Arts Commission, the City of Lodi and all of their representatives, volunteers and sponsoring organizations from any and all liability and responsibility for damages including, but not limited to loss suffered before, during or after the Art on the Square event or as a result of the display of my artwork, equipment and materials.
